**CONSENT AGENDA:**

**Letter from Caltrans dated April 26, 2018:** Commissioner Plasse asked if the reason for the letter was to re-route vehicles due to the Sutter Creek bridge project. Mr. Gedney responded that was part of the reason, but it was also due to an ongoing issue with traffic at the high school. There have been discussions with Caltrans regarding a temporary changeable message sign. Commissioner Forster commented that he believes there will be major issues at that intersection in the future because of speed and vehicles turning to go to Sutter Creek.

**2015 U.S. EPA Ozone Standard:** Commissioner Plasse commented that Amador County was in attainment and then the Federal EPA changed the minimum requirement from 0.75 particulate matter to 0.70 particulate matter. He noted that Amador County did not have worsening air quality conditions, the change in the standards put Amador County back into non-attainment.

**Ione Bypass Alternative Study:** Commissioner Forster asked about the process for the study and Commissioner Atlan replied that the project will go to the Ione Planning Commission before it goes back to the Ione City Council.

**Motion:** It was moved by Commissioner Plasse, seconded by Commissioner Forster, and carried to approve the Consent Agenda as discussed.

**REGULAR AGENDA:**

**Regional Surface Transportation Program for Fiscal Year 2018/19:** Mr. Gedney reviewed his staff report. He noted that the funding needs to be allocated and if it is programmed to the local jurisdictions, they will need to include their amount in their budgets. The eligibility requirements list how the funding may be used.

**Motion:** It was moved by Commissioner Forster, seconded by Commissioner Atlan, and carried to approve the allocation of \$513,007 in Regional Surface Transportation Program (RSTP) funds to Amador County and the incorporated cities by a formula previously established for distribution of excess Local Transportation Funds (LTF).

**Supplemental Income 457 Plan:** Mr. Gedney reviewed his staff report. Commissioner Atlan requested that the resolution state that any amendments to the Plan do not change the "no cost to employer" status. Commissioner Plasse commented that most plans are not administered by CalPERS, but with an investment house that works with the employees. Mr. Gedney noted that a couple of other plans were investigated but had higher fees for the employees. He added that staff was comfortable with this plan and it is voluntary on their part.

**Motion:** It was moved by Commissioner Atlan, seconded by Commissioner Plasse, and carried to approve implementation of a voluntary, CalPERS administered Supplemental Income 457 Plan as an additional ACTC employee benefit and to modify the resolution by adding that any amendments to the Plan do not change the "no cost to employer" status of the Plan and that ACTC has the right to cancel this Plan and move it to another carrier if any costs to ACTC are to be incurred.

**State Route 16 Relinquishments:** Mr. Gedney reviewed his staff report. Commissioner Colburn commented that ACTC has received no response from anyone including the State Senate or Assembly in regards to cooperation or mitigation. He feels the impact will be immense to Amador County's tourist industry in addition to the impact for local residents driving to Sacramento for medical appointments. He also believes there are weak spots in the environmental documents.

Commissioner Forster would like a timeline that explains when we started and that Amador County was left out of the process which shows the egregious errors that were created from the beginning. This will help to educate Andreas Borgeas, a Fresno County Supervisor running for State Senate. He would like to set up a meeting with Supervisor Borgeas and have a professional packet developed including maps that would explain our concerns. Included in the packet should be the testimony from Mr. Michael Penrose.

Public comment was received from Larry Rhoades, who asked if this issue had been brought before the California Transportation Commission (CTC). Commissioner Plasse noted that it hasn't been to a full hearing because Sacramento County postponed their relinquishment request. Commissioner Colburn noted that one of the CTC Commissioners attended the Plymouth roundabout ribbon cutting.

**Systemic Safety Analysis Report Update:** Mr. Gedney reviewed his staff report and gave an updated slide presentation. Mr. Gedney noted that the jurisdictions will decide if there are projects they want to submit for a Highway Safety Improvement Program (HSIP) grant. The next step is to continue to refine the projects and cost/benefit ratios. The consultants are available to help the jurisdictions with a limited number of HSIP applications.

**Motion:** It was moved by Commissioner Plasse, seconded by Commissioner Forster, and carried to approve staff recommendation to forward recommendations of the Systemic Safety Analysis Report to local jurisdictions.

**ACTC Commissioner Reports:**

Commissioner Forster commented that the County CAO and County Counsel will be meeting with a small group of people in the Buena Vista corridor Friday to speak to the people most impacted by the

heavy truck traffic. There will also be a meeting on July 2 at 6:00 pm in the Supervisors' chamber to give more information about the issues involved with the building of the new casino. The Supervisors are also negotiating mitigation measures including Regional Traffic Mitigation Fees (RTMF) with the Tribe.

Chairman Oneto noted that the County has started work on a project in conjunction with the City of Plymouth at the Fiddletown/Shenandoah intersection. It is estimated the work will take two months.

#### **ACTC Reports:**

- Mr. Gedney introduced Gregoria Ponce, Caltrans District 10's new liaison, who is replacing Carl Baker who retired.
- ACTC staff was unsuccessful in the partnership attempt with Caltrans on the ADA sidewalk project in Jackson. Caltrans will continue with the project with an estimated completion date of 2021/2022. There will be new curb ramps at the bridge approaches and a new sidewalk between Broadway and SR 88 (next to the real estate office).
- The RTMF MOU will be distributed to local jurisdictions.
- ACTC has hired a new intern through the Sustainable Transportation Planning Grant. Felicia Bridges has been working closely with Amador Transit for the last three weeks. She is enrolled in online classes through the University of Phoenix.

#### **Caltrans Report by Michele Demetras and Gregoria Ponce:**

- Ms. Demetras is in the process of talking with Caltrans staff regarding the SR 49/Drytown pavement section that has been added to over the years. There is a project planned for that area and maintenance will grind that area down. She will continue to monitor.
- The SR 49/Sutter lone Road intersection safety study will take 3-4 months. Ms. Demetras is working with the safety engineer on interim solutions.
- Ms. Demetras turned over the rest of Caltrans' report to Gregoria Ponce who is the new Chief of the Office of Rural Planning, District 10. She has a background in planning, Intergovernmental Review, land use, and has worked in the Governor' office in addition to working with the other Caltrans Districts.
- Ms. Ponce thanked Ms. Demetras for the job she has been doing in addressing the Commissioners and answering their questions.
- She added that she will be looking for other ways to better communicate with the Commissioners.
- Ms. Ponce and Mr. Gedney have had meetings to discuss the grants that were recently awarded to ACTC.
- District 10 recently started developing an Active Transportation Plan (ATP) and they will be reaching out to all of the counties in District 10 to help with developing a functional district level ATP.

Commissioner Colburn expressed his disappointment in communications between Districts 3 and 10 on the SR 16 relinquishment issue. He also commented on the SR 49/16 intersection and the merge/yield issue. Mr. Gedney reviewed the issue for Ms. Ponce. He noted that there was a field visit with Caltrans. They might do a pilot to see if the signs could be switched. Ms. Ponce will follow up.

Commissioner Plasse commented about Caltrans' ADA project in Jackson and that it seems to be a sidewalk to nowhere. Mr. Gedney updated Ms. Ponce that this is a safety project that was

implemented by Caltrans. Ms. Ponce will also follow up with the purpose and need for a sidewalk at that location.

Commissioner Atlan commented on the speed limits not being adhered to on SR 124 into lone from Plymouth and asked if it would be possible for some type of sign notifying drivers they are approaching a residential area. He added that on Main Street, asphalt had been put over the gutters, and some businesses are being flooded. In addition, the intersection at SR 124/Shakeley Lane and Preston Ave. has considerable congestion at certain times of day, especially when the prison shift ends. Ms. Ponce will follow up on these issues.

Chairman Oneto asked if Caltrans has responsibility for resurfacing 200' onto a county roadway from a State road that has been resurfaced, in this instance SR 124/Willow Creek Road. Ms. Ponce will follow up.

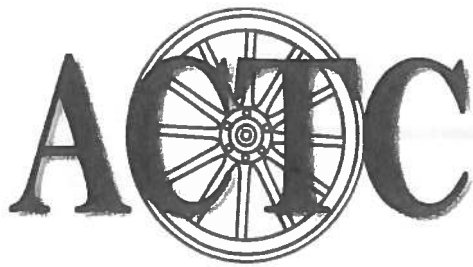

The Amador County Transportation Commission (ACTC) as the Regional Transportation Planning Agency (RTPA) for the Amador County region is pleased to support the application of the Amador County Department of Transportation and Public Works to the 2018 Better Utilizing Investments to Leverage Development (BUILD) grants program. Your support will enable the County to construct the State Route 88/Pine Grove Corridor Improvement Project.

The ACTC has worked closely with Amador County and the California Department of Transportation (Caltrans) for several years on planning and developing the SR88 Pine Grove Corridor Improvement Project. This project proposes to improve intersections and construct pedestrian and bicycle facilities to improve traffic flow, enhance safety, and strengthen the community character of Pine Grove. It is the highest priority project in our region. SR88 serves as an important gateway to our mountain communities and is a vital link for local, regional, inter-regional, and inter-state goods movement and travel. In addition, this project will mitigate safety concerns at one of the most troublesome locations in our region by providing a traffic signal and safer access for children who attend Pine Grove Elementary School.

Through our strong partnership with Amador County, Caltrans' District 10, and local stakeholders and businesses, the \$5 million requested from the BUILD program will leverage local traffic impact mitigation fees (developer fees), regional, and state funding sources. We believe that this project clearly aligns with the grant selection criteria to enhance safety, maintain a state of good repair, and improve economic competitiveness, environmental protection, quality of life, innovative considerations, partnerships with local stakeholders/businesses, and will leverage non-federal revenues (current and future) to the greatest extent practical.
